A fixed-price incentive contract is a fixed-price contract that provides for adjusting profit and establishing the final contract price by a formula based on the relationship of final negotiated total cost to total target cost. Fixed-price incentive contracts are covered in [subpart 16.4](#) , Incentive Contracts. See [16.403](#) for more complete descriptions, application, and limitations for these contracts.
